To The Department of City Planning:

The Venice Neighborhood Council's Land Use and Planning Committee (LUPC) has had several discussions with the Applicants representative and have attempted to secure the correct information about the C of O's and parking. It has come to our attention that while this process has been going on the Applicant is looking to secure from the City a DIR ruling and we The Community would like to have a voice in that process as is our right. The Applicant has retained a new representative Stephen Vitalich and we will work with him on the documentation. In advance of that discussion we would ask that the City not rule on the following cases: ZA-2012-246-CUB, DIR-2012-80-SPP, ENV-2012-81-CE, ENV-2012-247-CE at 1635 Abbot Kinney in Venice until we have complete the mutual process with the applicant.

To date, this applicant has provided insufficient information to support the case and to allow review with the community, but they are working to rectify this with Mr. Vitalich. Specifically, this has related to support the correct number of "grandfathered parking" rights, the FAR requirements as noted in the VCZSP Section 11.B.3.

Therefore, we request that City Planning and/or the Zoning Officer hold this case open and that if the exhibits change from what was originally submitted we request that the hearing be postponed and then re-noticed.
